3. I/we the Generator Owner further represent that I/we have not granted similar authority or permission to any other Subscriber or Account Holder for use in the CleanCounts Registry System(s) or any similar system(s). I/we further covenant that, for so long as this designation remains in effect, I/we shall not grant such authority or permission to any other Subscriber or Account Holder without first providing CleanCounts written notice revoking this designation.
4. CleanCounts may rely conclusively on this designation until CleanCounts receives written notice, signed by the Generator Owner, revoking or modifying the designation. CleanCounts has no duty to independently verify the Generator Owner's title to the Production Facilities or the Responsible Party's authority to accept this designation.
5. CleanCounts may suspend, disable, or decline to recognize the system access described in this designation at any time and without prior notice, in its sole discretion, including for suspected fraud, a security concern, a dispute between the Generator Owner and the Responsible Party, or noncompliance with the CleanCounts Operating System Terms of Use or the CleanCounts Fuels Registry Operating Procedures. This section governs CleanCounts's recognition of the designation only; it does not by itself end the designation as between the Generator Owner and the Responsible Party.

Capitalized terms not otherwise defined herein shall have the meanings given in the CleanCounts Operating System Terms of Use and CleanCounts Fuels Registry Operating Procedures.
